- Water Project Update **Hanelt** reported that a new site is being investigated for the sewer treatment plant. The Engineers are in discussion with parcel owners east of town. The CEQA process will be delayed until the new site is determined. Hopefully the delay will only be a few months. **Hanelt** attended the Community Development Block Grant for Mendocino County on 12/18/18. We will submit a report about a future request that would comply with CDBG housing guidelines. This would be a grant to help low-income parcel owners with their hook-up expenses from their homes to their new drinking water meters. Also, on January 29, 2019 there will be a Boonville Planners meeting at the Dining Room at the Fairgrounds. Several agencies will attend to answer questions. Mendocino County will send Jesse Davis from Building and Planning, and Trey Strickland from Health. North Coast Water Resources will be represented by Roy O'Connor who is the community outreach person for Clean Water (Sewer) systems for the North Coast region. All Directors are encouraged to attend.

- b. MCAFD Update **Mailliard** Ted **Williams**, 5th District Supervisor. was an invited guest. There was much discussion about 911 response. **Williams** expressed his opinion that the County has to start taking responsibility about 911 responses. The division of funding between police and fire has an overwhelming percent of money going to the police. There is a need for a Fire Marshall much like the Mendocino County Sheriff. **Williams** would like a formalized connection. Colin **Wilson** was also a guest and talked about the need for naming un-named roads in the County. Wilson wants to go to the Board of Supervisors to get roads named throughout the County. Roads need to correlate to CAD/911/parcels, etc. He wanted support from the MCAFD and they gave it to him.
