16. OLD BUSINESS:

- a. **Hanelt** reported that there is no update on the Drinking Water project. The Sewer project has been set back by having to find a new site for the treatment plant. A couple of property owners have been approached. The current possibility is slightly west and across from the CalFire station on 128. The Environmental Review (CEQA) will have to be delayed until studies can be done on the new site if it works out. Hopefully the process will be completed by late February. The next meeting is a Boonville Planner meeting on January 29th at 7 pm in the Fire House meeting room. Attendees will be our new Supervisor, and local agency representatives, and our engineers. All Board members are encouraged to attend. The newsletter idea was discussed and after the Jan 29th meeting we will start developing it.

- c. EOA Update **Avila** The postponing of the EOA has been going on now for around five years. There has been much discussion between the Board about the negative effects this has created. Recently it has been suggested by Coastal Valley EMS Agency that the Anderson Valley ambulance go outside of our district if needed during ambulance drawdown in the inland corridor. We do not have the capacity to do so: there is only one ambulance in Anderson Valley and it would not be prudent to send it out. The Board agrees and supports this.
